I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY INJURIES OR DAMAGES WHICH MAY OCCUR TO ME AS A RESULT OF MY PRESENCE AT HARBOR HUMANE SOCIETY. I ACKNOWLEDGE THAT MY SAFETY IS MY RESPONSIBILITY ALONE, AND NOT THE RESPONSIBILITY OF HARBOR HUMANE SOCIETY, OR ANY OF THEIR SUBCONTRACTORS, AGENTS, OFFICERS OR EMPLOYEES, AND THAT THEY SHALL NOT BE LIABLE FOR INJURIES OR DAMAGE, IF ANY, SUSTAINED BY ME ARISING OUT OF MY PARTICIPATION IN ANIMAL CARE OR MY PRESENCE AT THE ANIMAL SHELTER. I agree to follow all safety rules and procedures on the site. As a volunteer, I understand that I will not be paid or entitled to benefits of any kind, and that I am not covered under any Worker's Compensation law. I also agree that I am not a third party beneficiary of any agreement.

I, for myself and on behalf of my family, heirs, executors, administrators, personal representatives, successors and assigns, hereby fully and forever release, acquit and discharge Harbor Humane Society, and their
